I. Call to Order and Roll Call

President Symone Bounds called the Mississippi University for Women Alumni Association (MUWAA) annual meeting to order at 4:06 pm

II. Association President's welcome

President Bounds thanked all for coming and asked all to take the time to soak in each memory made this weekend.

III. President's Welcome

President Nora Miller welcomed all in attendance. She briefed us on the university's strategic plan and gave us an overview of where The W stands in the IHL system. As of this meeting, The W has the highest number of degrees for every 100 students (36.8 for every 100 students), our MA in Teaching online program is ranked 3rd in the nation, The W is still ranked 1st in the state for Nursing, with a 96% percent pass rate on Nursing Board exams, and we had the second highest number of degrees in our history in 2022- a total of 927 conferred degrees.

President Miller also went over some exciting renovation projects including a \$625,000 grant for Plymouth Bluff renovations, and she is hoping to hear an answer about a proposed 26 Million dollar expansion for Fant Hall. She also stated that there will be an exciting announcement tonight at Magnolia Mingle.

In May of 2022, The W announced that we were in the beginning stages of a name change based on results from focus groups, surveys, and meetings with legislation. In December 2022, it was announced that the name change process would be postponed for a year. President Miller stated that the name change process will not be going away.

This Committee will also carry out the Nominations process for the upcoming year's Nominations & Elections Committee to be elected by the MUWAA Board of Directors.

- The Office of Development & Alumni processed the Election results and delivered to the committee on March 19, 2024 (extra time was allowed for any paper ballots to arrive).
- The Certified Results were sent to the MUWAA President and the Office of Development & Alumni

Please summarize the committee's accomplishments for the year:

A total number of 39 Nominations were received by the Office of Development & Alumni

- 14 nominees were not eligible to serve
- 1 individual was not eligible due to being a university employee
- 3 individuals received more than one nomination
- 16 individuals were determined eligible to serve
- 8 individuals accepted nominations for consideration (11 for Directors, 1 for President-Elect)
- The Nominations and Elections committee determined that the traditional style of slate with the write-in options as stated in the By-Laws as opposed to the contested style of ballot presented in 2021-2022.
 - o 5 alumni were placed on the ballot for Board Director
 - o 1 alumni was recommended for President-elect

The total number of ballots cast was 161. Six (6) of those ballots were paper ballots. Of the above total, the following breakdown is detailed:

Goal 1: Review and consider amending MUWAA Bylaws to include a list and description of current Special Committees by the Winter Board Meeting for approval.

Goal 2: Address tabled items requiring Bylaws and P&P action from 2022-'23 BoardYear.

Goal 3: Audit and prepare a motion to change the Names associated with MUW in the MUWAA Bylaws + P&P after the Legislative motion.

Please summarize the committee's accomplishments for the year.

Progress in Achieving Goals for 2023-2024 Board Year:

Goal 1: The Bylaws Committee, with input from Committee members and Committee Chairs, revised and re-wrote the descriptions that had been used for the Special Committees. We presented these descriptions to the Board, and after some discussion, the Board approved the descriptions to be placed in the Policies and Procedures document.

- A. Following the approval, we placed the Descriptions in a new Appendix to the Policies and Procedure document, which is attached to this document.

- B. The bylaws now include references to the special descriptions published in the P&P. All changes to the Bylaws must be approved by the General Membership and will be done later, which the General Membership will approve at the appropriate time.

Goal 2: We addressed three tabled items requiring Bylaws and P&P action from '22-'23 Board Year.

- A. The Bylaws Committee was charged with addressing three items to place in the P&P and Bylaws.
- B. First, as a result of past decisions by the Board, we were charged to make sure that all references to time frames in the P&P were fiscal year time frames. All “yearly” or “annual” refer to July 1-June 30.
 - a. We have rewritten the P&P to reflect the Fiscal year time frame. We will do so in the Bylaws as well.
 - b. We have placed the MUWAA First Generation College Student Scholarship information into the P&P document.
 - c. We await information from MUW to complete placing the Undergraduate Research Scholarship Information into the P&P.

Goal 3: We stand ready to audit and prepare a motion for a Name Change of MUWAA Bylaws + P&P if and when this occurs in the future.

1. Research & consider recommendations to the MUWAA board regarding committee name change that aligns better with the committee description + mission.
2. Identify and adhere to Policies & Procedures pertaining to Alumni Awards process with goal of opening nominations to Association no later than the first week of November.
3. Partner with MUW Enrollment Team to fine-tune new process utilizing the new electronic application to increase student scholarship applicants by April 1, 2024, deadline.
4. Collaborate with both MUWAA Public Relations & Digital Marketing Committees to promote recognition of the Faculty, Student, & Alumni award recipients.

Please summarize the Committee's accomplishments for the year.

1. Created a Google doc to input ideas on committee name change, and we had seven proposed ideas. As a committee, we voted on a name to propose to the Alumni Association; however, with the expected implementation of the Alumni Recruitment Team being a dotted line to the Recruitment and Retention Committee, the committee name will remain Recruitment and Retention Committee.
2. Piloted moving the nominations window for Alumni Awards up one month from November to October, and the change was very successful.
3. Proposed that the MUWAA Board of Directors update the MUWAA policies and procedures around the Alumni Awards and nominations timeline.

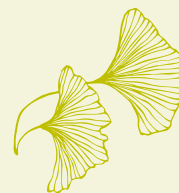

President Symone Bounds called the Mississippi University for Women Alumni Association (MUWAA) annual meeting to order at 4:06 pm

II. Association President's welcome

President Bounds thanked all for coming and asked all to take the time to soak in each memory made this weekend.

III. President's Welcome

President Nora Miller welcomed all in attendance. She briefed us on the university's strategic plan and gave us an overview of where The W stands in the IHL system. As of this meeting, The W has the highest number of degrees for every 100 students (36.8 for every 100 students), our MA in Teaching online program is ranked 3rd in the nation, The W is still ranked 1st in the state for Nursing, with a 96% percent pass rate on Nursing Board exams, and we had the second highest number of degrees in our history in 2022- a total of 927 conferred degrees.

President Miller also went over some exciting renovation projects including a \$625,000 grant for Plymouth Bluff renovations, and she is hoping to hear an answer about a proposed 26 Million dollar expansion for Fant Hall. She also stated that there will be an exciting announcement tonight at Magnolia Mingle.

In May of 2022, The W announced that we were in the beginning stages of a name change based on results from focus groups, surveys, and meetings with legislation. In December 2022, it was announced that the name change process would be postponed for a year. President Miller stated that the name change process will not be going away.

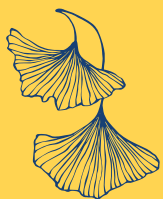
